ORDER

1. Whereas, the Director General of Civil Defence and Commandant General of Home Guards, Assam, Beltola, Guwahati – 28 invited Bids from eligible bidders vide this office e-Tender No. CG (Q)1/2022-23/16 Dated. 28.03.2022 for supply of Dry-Ration Commodities to the personnel of ASRF Bn-I, II and AISF Bn-I, II for the Financial Year 2022-2023.
2. Whereas, subsequently a write petition W.P. (C) No. 2678/ 2022 was filed in Honorable Gauhati High Court by petitioner East India Supply Centre, SRCB Road, Fancy Bazar, Guwahati.
3. Whereas, Honorable Gauhati High Court, vide its interim order dated 19-04-2022 allowed the petitioner to participate in the bid but stayed the further proceedings in the opening of the said e-tender till the returnable date and/or without the leave of the court.
4. Whereas, in the meantime the above petitioner in an Interlocutory Application dated 05-04-2023 no. (C) 978/ 2023 in WP (C) 2678/2022 before the Honorable Gauhati High Court prayed to withdraw the WP (C) 2678/ 2022.
5. Whereas, the Honorable Gauhati High Court in I.A.[C] no. 978/2023 in WP (C) 2678/2022, vide its order dated 23-05-2023, dismissed the writ petition on withdrawal, vacating the interim order passed if any.
6. Whereas, the bid validity has already expired on 31.03.2023 as per Clause-10 of this office e-Tender No. CG (Q)1/2022-23/16 Dated. 28.03.2022.

Therefore, in view of the above, E-tender No. CG (Q)1/2022-23/16 Dated. 28.03.2022 published for procurement of Dry Ration commodities for the AISF & ASRF Bn personnel for the Financial Year 2022-2023 is hereby cancelled.


